of Duck Pond, so called; thence in a straight line to the place of beginning.

SEC. 3. Said Westport Fire District is hereby authorized and empowered to provide a sufficient supply of water for fire and other public purposes by contract with the Westport Water Company, and also to assume and carry out the contract now existing between the town of Westport and the Westport Water Company as fully and completely as if made in the name of said fire district; to organize and maintain fire, hook and ladder, and hose companies, and to purchase hose and other appliances for the extinguishment of fire, and to provide suitable buildings and places for keeping the same; to establish and enact all by-laws that may be deemed necessary and expedient to carry out the provisions of this act; *provided*, that the same are not in violation of the laws of this state or of the United States. And for these purposes the said Westport Fire District shall have the same powers and officers and proceed in the same manner as a school district for school purposes.

SEC. 4. The selectmen of the town of Westport or a majority of them are authorized and directed to call the first meeting of the legal voters of said district at such time and place within the said district as they may determine.

AMENDING THE CHARTER OF THE GREENWICH WATER COMPANY.

Resolved by this Assembly: That the Greenwich Water Company may from time to time increase its capital stock to an amount not exceeding three hundred thousand dollars, but such addition or increase shall be made only by a major vote of the stockholders present in person or by proxy at a meeting specially warned for that purpose.

INCORPORATING THE PEOPLE'S LIGHT AND POWER COMPANY.

Resolved by this Assembly: SECTION 1. That Warren J. Livermore, Edwin Evans, Richard Sugden, Nathaniel Myrick, Isaac L. Prouty, Joseph W. Temple, Charles H. Allen, Charles A. Bemis, William A. Barr, and Robert Hay, and such other persons as shall associate with them for that purpose, be and they are hereby constituted a body politic and corporate by the name of The People's Light and Power Company, and by that name said corporation shall have all the rights and powers enumerated in section 1906 of the general statutes, and such rights and powers as by law pertain to corporations. Said corporation shall have its office and place of business in the borough of Danielsonville.

SEC. 2. Said corporation is hereby authorized and empowered to
