AMENDING THE CHARTER OF THE VILLAGE WATER COMPANY
OF SIMSBURY.

Resolved by this Assembly: That the resolution incorporating The Village Water Company of Simsbury, approved May 15, 1903, is hereby amended by striking out in the ninth section the words "within the towns of Simsbury and Bloomfield" and inserting in lieu thereof the following words: "within the town of Simsbury," and by adding at the end of section nine the following, viz.: "All of the provisions of this resolution are subject to the condition that the powers herein granted shall not be exercised to deprive The Simsbury Water Company of any part of the water which it now enjoys or to which it may be entitled under the provisions of its charter, or to take any water from the Farmington river."

REVISING THE CHARTER OF THE WOODMONT IMPROVEMENT ASSOCIATION AND CHANGING ITS NAME TO THE WOODMONT ASSOCIATION.

Resolved by this Assembly: Section 1. That all of the electors of this state, who are taxpayers in the town of Milford, and who have been domiciled for one month during the year last past in the town of Milford, and within the territory included within the following limits, to wit: All that territory in said town of Milford, on the shore of Long Island sound, bounded northerly and westerly by a line beginning at a point in the center of the bridge over Oyster river, near the property of the Rev. Dr. Anderson; thence from said bridge northerly at right angles to said bridge until the line reaches a point two hundred feet northerly of the northerly side of the highway in which said bridge is located; thence southwesterly, parallel to and two hundred feet distant from said highway, to the northerly side of Chapel street, near the house of John W. Merwin; thence westerly, along the northerly side of Chapel street, to a point opposite the westerly line of the Woodmont chapel property; thence southerly across said Chapel street along land of said chapel society; thence easterly along land of said chapel society to Merwin avenue; thence southerly along the westerly side of said Merwin avenue to a clump of three large trees; thence southwesterly in a straight line to the top of Barrel rock so-called, to the southerly boundary line of the town of
