Act 139. Repealing Former Laws Water and Sewer.

ACT 139

AN ACT

TO AMEND SECTION 8 OF AN ACT ENTITLED, "AN ACT RELATING TO THE HONOLULU WATER AND SEWER WORKS AND REPEALING FORMER LAWS RELATING THERETO", PASSED BY THE LEGISLATURE OF 1913.

Be it Enacted by the Legislature of the Territory of Hawaii:

SECTION 1. Section 8 of an Act passed by the Legislature of the Territory of Hawaii at the Regular Session of 1913, entitled, "An Act Relating to the Honolulu Water and Sewer Works and Repealing Former Laws Relating Thereto", is hereby amended to read as follows:

"Section 8. Sections 552 to 573, both inclusive, of the Revised Laws, Acts 105 and 112 of the Laws of 1909, and Act 158 of the Laws of 1911, are hereby repealed, provided that the repeal of said Sections 553, 554, 557, 558 and 559 and said Acts 112 and 158 shall not be effective until the transfer of the water and sewer works to the City and County of Honolulu or its successor shall be made as provided in Section 1 of this Act, and provided further that until such transfer all of the powers and duties conferred upon or required of the Superintendent of Public Works by said Sections 553, 554, 557, 558 and 559 and said Acts 112 and 158 shall be exercised and performed by said Superintendent subject to the direction of the Governor. The sum of Thirty Thousand Dollars or so much thereof as may be necessary is hereby appropriated out of the general revenues of the Territory for the operation and maintenance of the Honolulu Water and Sewer Works, the same to be deemed an advance to the special fund of said water and sewer works and to be reimbursed to such general revenues as soon as may be out of such fund or, if such fund shall be insuf-

ficient for the purpose, out of the general revenues of the City and County of Honolulu, before January 1, 1915."

SECTION 2. This Act shall take effect on July 1, 1913.

ACT 140

AN ACT

TO REIMBURSE CERTAIN LABORERS AND MATERIALMEN FOR LABOR AND MATERIAL FURNISHED AND USED IN THE CONSTRUCTION OF NEW BUILDINGS AT THE BOYS' INDUSTRIAL SCHOOL AT WAIALEE, OAHU.

Be it Enacted by the Legislature of the Territory of Hawaii:

SECTION 1. There is hereby appropriated out of any moneys in the Treasury not otherwise appropriated the sum of \$4,000.00, or so much thereof as may be necessary to reimburse the laborers and materialmen who furnished labor and material used in the construction of new buildings at the Boys' Industrial School at Waialeale, Oahu, during the year 1912, and whose claims have not been paid.

SECTION 2. No portion of such sum shall be paid to any claimant until he shall satisfy the Superintendent of Public Works that the labor or material for which such claim is made, was actually used in the construction of the buildings aforesaid and that the same has not been paid, and until such claimant shall execute and deliver to the Superintendent of Public Works a good and sufficient legal assignment to the Territory
