WATER DISTRICT.

AN ORDINANCE amending an ordinance entitled "An ordinance establishing and defining the water district of the City of Burlington, Iowa."

Be it ordained by the City Council of the City of Burlington, Iowa:

Section 1. That an ordinance entitled "an ordinance establishing and defining the water district of the City of Burlington, Iowa," is hereby amended by inserting and substituting in lieu of Section 2 of said ordinance, the following:

Sec. 2. Beginning on the west side of the Mississippi river at the section line between sections 28 and 33, township 70, range 2; thence west along said section line to the corner of sections 28, 29, 32 and 33, same township and range, thence north along the section · line between sections 28 and 29 to a prolongation of Silver street; thence west along said prolongation and along Silver street to Ridge Row; thence west across Ridge Row and along the north line of lot 122 in W. D. Gilbert's addition; thence along the west line of said W. D. Gilbert's addition and the prolongation thereof to the east and west center line of section 29, township 70, range 2; thence west along the center line of said section 29 to the west line of lot 8, in Leonard's subdivision, thence south along the west line of said lot 8 to Pearl street; thence across Pearl street to the northwest line of lot 21 in Leonard's subdivision; thence in a southwesterly direction along said northwest line of said lot 21 to and across Sunnyside Avenue; thence in a southeasterly direction along Sunnyside Avenue to the northwest line of lot 1, in Leonard's second subdivision; thence southwesterly along the said northwest line of said lot 1 to the southwest corner of said lot; thence southeasterly along the southwest line of said lot 1 to the southeast corner of said lot; thence south along the west line of lot 3 in Leonard's second subdivision to the north line of Aspen Grove cemetery; thence east along the north line of Aspen Grove cemetery to the east line thereof: thence south along the east line of said cemetery to Corse street;

Pleasant street to the west line of lot 2 in Hyde park; thence south along said west line and a prolongation thereof to the north line of Heintz and Slingluff's subdivision; thence westerly along said north line to the west line of said subdivision; thence south along said west line to Agency street; thence westerly along Agency street to Shields street; thence south along Shields street to St. Paul street; thence east along St. Paul street and a prolongation thereof to the western boundar, line of Leebrick's second addition; thence southwesterly along said western boundary line to Oak street; thence south along Oak street to Spray street; thence east along Spray street to Plane street; thence south on a prolongation of Plane street to West Avenue; thence west along West Avenue to South Avenue; thence south along South Avenue to Mason street; thence east along Mason street to the west line of lot 6 in decree subdivision of Marlow estate; thence southwesterly along said west line to the southwest corner of said lot 6; thence easterly along the south line of said lot 6 to the west line of lot 3 in said subdivision; thence south along the west line of lots 3 and 4 in said subdivision to the south line of said lot 4; thence east along the said south line to Summer street; thence east across Summer street and along Barrett street to Thirteenth street; thence south along the west line of lot 4 in Wade's subdivision of section 8 to Harrison Avenue; thence east along Harrison Avenue to Bischoff street; thence south on Bischoff street to Crapo Avenue; thence east on Crapo Avenue to Madison street; thence south along Madison street to Whitewood street; thence east along Whitewood street to the west line of Ervin's subdivision of a part of sections 8 and 9, township 69, range 2; thence east along the line between lots 2, 3, 4, 5, 6, 7, 8, 9, 10, 11 and 12 in said subdivision to the east line thereof; thence south along said east line to Moltke street; thence east along Moltke street and a prolongation thereof to the Mississippi river; thence northerly along the west side of said river to the place of beginning.
