

of Daviess county beginning at the mouth of Burnet's fork, on North Panther creek; running thence with Panther creek to where it crosses the Litchfield road at the covered bridge; thence with the original line of the Uppertown precinct, as established by law, to where it strikes Burnet's fork, near the residence of Henry Miller; thence with Burnet's fork to the beginning of precinct. And on the petition of a majority of the voters within the proposed boundary, the said county court shall establish such civil district or precinct; but such district or precinct, whenever erected, shall constitute an election precinct or district only for the purposes of the act of the General Assembly, approved January 26th, 1874, and entitled "An act to regulate the sale of spirituous, vinous, and malt liquors in this Commonwealth;" and for said purpose the said county court shall, as to said precinct, exercise the powers and discharge the duties prescribed therein as to other election precincts, and shall also have the power to fix the day of election in said civil district or precinct when: Provided, That this act shall not be construed as preventing the county court from establishing a precinct or civil district for other purposes within or over any part of said included territory.

§ 2. This act shall take effect from its passage.

## CHAPTER 1349.

AN ACT to amend the charter of the Louisville Water Company.

Be it enacted by the General Assembly of the Commonwealth of Kentucky:

- § 1. That it shall be the duty of the Louisville Water Company to furnish water to the public fire cisterns and public fire plugs or hydrants of the city of Louisville for fire protection free of charge.
- § 2. The sinking fund of the city of Louisville being the owner of the stock of the Louisville Water Company, and said water company, by virtue thereof, is the property of the city of Louisville, therefore the Louisville

Water Company is hereby exempted from the payment of taxes of all kinds of whatever character, State, municipal, and special.

§ 3. This act shall take effect from and after its passage.

## CHAPTER 1351.

AN ACT to amend the road law of Greenup county, and to repeal chapter
67 of Session Acts of 1879'-80, approved March 24, 1880.

Be it enucted by the General Assembly of the Commonwealth of Kentucky:

- § 1. That the road tax for Greenup county is hereby fixed at ten cents on each one hundred dollars in value of taxable property assessed for State revenue purposes.
- § 2. That chapter sixty-seven of Session Acts of 1879 and 1880, entitled "An act to amend the road law of Greenup county," approved March 24th, 1880, be, and the same is hereby, repealed; and sections fifteen, seventeen, and eighteen of chapter eleven hundred and thirty-nine of Session Acts of 1871, entitled "An act to amend and reduce into one the several acts in relation to the road law of Greenup county," are hereby re-enacted in full force and effect, except as amended by the first section of this act; and all laws and parts of laws in conflict with this act are hereby repealed.
- § 3. This act shall take effect and be in force from its passage.

## CHAPTER 1353.

AN ACT to repeal the charter of the town of Sanders, Carroll county, and re-incorporate the same.

Be it enacted by the General Assembly of the Commonwealth of Kentucky:

§ 1. That all acts and parts of acts incorporating the town of Sanders, or establishing a police court therein,
