## CHAP. 155.

PASSED

be so construed as to give to the members of said lodge, any right or title to any other part of the said market house and premises, except the room or rooms erected by them.

Right of inspection  
&c. reserved

SEC. 5. *And be it enacted*, That it shall and may be lawful at any time for the General Assembly to demand a statement of the amount of property, real and personal, belonging to the said corporation, and of the debts due to and from the said corporation, and the purposes for which disbursements shall have been made, and shall also have the right to authorise one or more persons to inspect such general accounts in the books of the corporation, as shall relate to such statement.

Right to alter or  
annul reserved

SEC. 6. *And be it enacted*, That the General Assembly of Maryland reserves the right to change, alter or annul this act of incorporation at any session hereafter.

## CHAPTER 155.

Passed Mar. 15, 1836

*An act for the benefit of the person or persons who may or shall become the purchaser or purchasers of the property of the Frederick Water Company.*

Preamble

WHEREAS, it is represented that the works and property of the said company are about to be sold by the sheriff of Frederick county, and that the convenience, comfort and health of the citizens of Frederick would be preserved, by the maintainance of the works and property of the said Water Company in their present condition:—Therefore.

Right of purchaser  
confirmed

*Be it enacted by the General Assembly of Maryland*, That any person or persons, corporation or corporate bodies, who may or shall become the purchaser or purchasers of all the works and property of the Frederick Water Company, shall be entitled to, and shall have and enjoy all the rights, privileges, powers and immunities, which were had, held, used and enjoyed, by the said Frederick Water Company, by virtue of the act of Assembly, entitled, an act to introduce wholesome water into the city of Frederick, and its

several supplements, and to have and hold the same unto the said purchaser or purchasers, their heirs, or successors, or assigns, in as full and ample manner as they were had, held, used, and enjoyed by the said company, and that the person or persons corporate, or corporate bodies, who may or shall become such purchaser or purchasers, their heirs, successors, or assigns, shall be subject to and perform all and every the duty and duties, and obligations imposed upon and required of the water company, by the said act of Assembly, and its several supplements. CHAPTER 156.

*An act relating to the Alms House of Harford county.* Passed Mar. 15, 1836

*Be it enacted by the General Assembly of Maryland,* Levy 500 dollars  
That the commissioners of Harford county, be and they are hereby directed to levy and raise five hundred dollars, to be paid to the trustees of the poor of said county, and by them applied to the payment of the balance due on the purchase of the Alms House Farm.

CHAPTER 157.

*A supplement to an act, entitled, an act for the re-valuation of the real and personal property in Frederick county.* Passed Mar. 18, 1836

SECTION 1. *Be it enacted by the General Assembly of Maryland,* That from and after the passage of this law, that in every case where the compensation is fixed and allowed, by the commissioners of the tax to their clerk, in said county, that that allowance shall be final, and the Levy court shall place the same on the assessment of the county. Compensation of clerk of com. of tax

SEC. 2. *And be it enacted,* That the word, extra, in the first line of the third section of the original act, to which this is a supplement, passed at December session, eighteen hundred and thirty-four, chapter twenty-two, shall be void and of non-effect. "Extra." &c. repealed
