CHAP. CLXVIII.

An Act to authorise and empower the Levy Court of Anne-Arundel County to Passed Feb 14, 1820 assess and levy a sum of money for the purpose therein mentioned.

Be it enacted, by the General Assembly of Maryland, That the Court authorised to inquire into levy court of Anne-Arundel county, be and they are hereby directed elaim of executors of Walter Clagett, deceas- of Walter Clagett, &c. ed, relative to three hogsheads of tobacco which was sold by the inspector at Beard's warehouse, in said county, on account of no person claiming the same, and for the purpose of paying the warehouse rent due on said tobacco; and if it shall be made to appear to their satisfaction, by the production of the certificate granted by the inspector or otherwise, that the said Walter Clagett, deceased, was the owner of said tobacco, and that the same was sold by order of the levy court of said county, and the money applied to the use of said county, then and in that case they are hereby authorised and empowered to assess and levy on the assessable property of said county, the amount received by the levy court for said tobacco, and after deducting the expenses for warehouse rent, and so forth, to pay the balance to the executors of the said Walter Clagett, or to their order.

CHAP. CLXIX.

A Supplement to act, entitled, An act to incorporate a Company under the name Fassed Feb 141826 of the Hydrant Company of Port-Tobacco.

WHEREAS the last general assembly of Maryland passed an act Preamble to incorporate a company under the name of The Hydrant Company of Port Tobacco: And whereas in the said act there is no appeal to the county court reserved to any person or persons who may consider him or themselves aggrieved by any imposition or tax which the said corporation may impose: And whereas sundry inhabitants of the said town have petitioned this legislature, complaining of an oppressive tax laid by the said corporation; and as it is necessary and just that some tribunal should be authorised to hear and inquire into such alleged grievances, so that if there be cause, that the same

Be it enacted, by the General Assembly of Maryland, That county court to it shall and may be lawful for the county court of Charles county, relative to illegal upon the petition of any person or persons complaining of any illegal or oppressive tax, laid or to be laid by the said corporation, to hear and inquire into the same, and to pass such order in relation thereto as the said corporation in justice ought to do, and it shall be the duty of the corporation to conform thereto.
