HAVERHILL AQUEDUCT COMPANY.

PETITION FOR AUTHORITY TO SELL ITS PROPERTIES TO THE
PRECINCT OF HAVERHILL CORNER.

Transfer and sale — Purchase of water utility by a municipality.

1. A small water utility was permitted to sell its property and plant to a precinct of the town.

REPORT.

GUNNISON, *Chairman.*

This is a petition by the Haverhill Aqueduct Company, a New Hampshire corporation operating a small water utility in the town of Haverhill, for authority to sell all of its property of every description, excepting its franchise rights, to the Precinct of Haverhill Corner for the sum of \$64.

The stockholders have voted unanimously to make this sale with the commission's approval, and no one objects.

We find it is for the public good that the petition be granted and an order will issue accordingly.

Worthen and Storrs, commissioners, concurred.

ORDER No. 953.

Upon consideration of the foregoing report, which is made a part hereof, it is

ORDERED, that the consent of this commission be and hereby is given to the Haverhill Aqueduct Company to sell and convey all of its property of every description, exclusive of

franchise rights, to the Precinct of Haverhill Corner for the sum of sixty-four dollars (\$64), and it is

FURTHER ORDERED, that after said sale and conveyance the said Haverhill Aqueduct Company may permanently cease to do business as a public water utility.

PETITION FOR AUTHORITY TO THE FIRST PETITIONER TO
PURCHASE THE PROPERTY OF THE SECOND PETITIONER.

Transfer and sale—Electric utility—Public good considered.

1. It was found to be for the public good to permit the acquisition of a small electric utility by a larger utility operating successfully in adjacent localities and able to render continuous service, at a purchase price that was found to be fair.

GUNNISON, *Chairman.*

This is a petition by the Twin State Gas & Electric Company for authority to purchase of Herman H. Sanborn, and by Herman H. Sanborn for authority to sell to said company, his electric public utility plant at Sanbornville for the sum of \$3,500, \$1,000 of which is to be paid in cash and the balance in three notes, one for \$1,000, another for \$1,000, and
