We the undersigned do
hereby certify that we desire to form and do
hereby form a Company Corporate, under and
by virtue of the laws of the State of Nevada,
by the name of
The Elko Water Company.

County That the object of said Corporation is to carry
on and conduct the business of Ditching
Manufacturing and Domestic purposes and
for supplying the Town of Elko in said Elko
with Water and Water Works

The amount of the Capital
Stock of said Corporation shall be divided
into Twenty-one (21,000) Thousand Shares of
the par value of Ten Dollars (\$10) Each

The said Corporation shall
exist for the term of Fifty Years, and its
Concerns shall be managed by a Board
composed of three Trustees,

The principal place of
business of said Corporation shall be in
the County of Elko, Nevada, and at the town
of Elko therein. Where an office shall
be kept for that purpose,

The following persons to wit: H. A. Larnille

Directors to Manage the Concerns of said
