### Records of Corporations

In December of 1862 the Nevada Territorial Assembly passed the first corporations law of the territory. (Statutes, 1862: 162) The articles of incorporation named the purpose of the corporation, the amount of capital stock, the trustees, and the town or county which was the principal place of business. Copies of these articles were filed with the county clerk of the county of the place of business and with the Secretary of the territory. This act was repealed by the first State Legislature in 1865. (Statutes, 1865: 365)

This volume, called Certificates of Incorporation Volume 2, contains the articles of incorporation filed with the Secretary of the Territory from August 1, 1863 to May 16, 1864. An index to this volume exists and has been filmed at the beginning of this volume.

The original documents that still exist are in the Nevada Territorial records in the State Archives. They are indexed by corporation name, names of individuals and date of filing in the Name Index to the Nevada Territorial Records, compiled by Charles A. M. Maze and published by the Nevada State Library and Archives in 1994.



## Certificate of Incorporation of the Mill City and Water Company

This is to certify that under and in conformity with the provisions of an Act of the Legislature of the Territory of Nevada, Entitled "an Act to provide for the formation of Corporations for certain purposes" approved December 25<sup>th</sup> 1862 and the several Acts amendatory thereof, the subscribers have this day formed and set on foot into a Corporation, Association or Company and do declare as follows:

First "The Corporate Name of the Company shall be "Mill City and Water Company"

Second "This Company is formed for the purpose and object of Claiming or acquiring and holding Four Sections of Public Land, to organize Suburbs and lay out a Town to be known as Mill City at a point near the Humboldt River and the Humboldt Canal as will be more fully designated by our

Recorded Survey; also to locate and hold a water ditch, to collect and bring the water from the hills as indicated by our statutes, and to furnish, construct and lay down all necessary aqueducts and water pipes for the <sup>purpose</sup> of supplying the inhabitants of Mill City with a sufficient quantity of water for all domestic and fire purposes, at such rates and charges as the County Commissioners in and for the County of Humboldt shall allow. We further claim the suitable Building Lots of every kind, within the boundaries of our Survey of four Sections for building or other purpose of the Company, also for the erection of mills, acquisition of ores and minerals and mining the same.

Third The Capital Stock of the Company shall be three Hundred Thousand dollars, divided into three thousand shares of one hundred dollars each.

Fourth The said Corporation shall continue for fifty years unless sooner discontinued or dissolved according to Law.

Fifth The number of Trustees who shall manage the concerns of said Company for the first three months shall be eight, five of which shall constitute a quorum for the transaction of the business of the Company and their names are J. Ginaca, C. W. Shang, L. B. Ritter & Gintz, J. A. Allgauer, G. B. Andonetti & Lailey, Lewis Greenfield.

Sixth, The temporary place of business of said Company for the first six months shall be Humboldt City and after the expiration of said Term of Six months the principal place of business shall be at mill City.

## Certificate of Incorporation of the Sprague Silver Mining Company

Territory of Nevada } S.  
County of Lander }

The undersigned having this day formed a Corporation for the purpose of Mining, do hereby certify that the name of said Corporation shall be the Sprague Silver Mining Company.

That the object of said Corporation is to carry on and conduct the business of Mining on a certain vein or Lode known by the name of the Sprague Lode and situated and recorded in the District of Reese River.

The amount of the Capital Stock of said Corporation shall be One Hundred thousand Dollars, which shall be divided into One thousand Shares One Hundred Dollars Each. The said Corporation shall exist for the Term of Fifty years.
