The second secon MANHATTAN WATER WORKS.

The President and Directors of the MANHATTAN COMPANY, have Resolved the following REGULATIONS for the better Government of the WATER WORKS.

1. Subscribers for water shall not supply other families or persons, without written permission from the water-office, otherwise the supply will be stopped and the amount of payment forfeited.

2. No lateral pipe, in any instance whatever, shall be connected with the main logs of conduit, without being authorised by the office.

3. Altho' the company employ men for the purpose of laying and repairing lateral pipes, yet the inhabitants are not precluded from employing other workmen-therefore no deduction will be made from the annual stipulated price for an alleged want of water, be the cause what it may, provided the main pipes of conduit are supplied, which is all the Company guarantee to subscribers.

4. The lateral pipes, in all instances, to be kept in repair by the occupants or owner of the premises: and for the prevention of imposition, the following rates are deemed a fair compensation for laying and remaining solid pipes. pairing said pipes, to be paid by individuals employing the workmen. The present price for laying lead pipe, for 3-4th inch bore, 50 cents, and for wood pipe, 38 cents for each foot, including the digging, and reparation of the transfer o ving the streets. For digging to the tube, in order to let on the supply of water, 75 cents. For each joint of solder 50 cents. For each cock, suitable for the pipe, from 50 to 100 cents. For soldering on a cock, 50 cents. For forcing a pipe, 25 cents. All branch-pipes are strictly prohibited.
5. The following rates are now fixed upon for the use of water, pay-

able half yearly, in advance.

For Dwelling Houses, containing from 1 to 3 fire places, five dollars-4 do. six dollars—5 do. six dollars fifty cents—6 do. seven dollars fifty cents—7 do. 8 dollars seventy-five cents—8 do. ten dollars 9 do. eleven dollars twenty-five cents—10 do. twelve dollars fifty cents—11 do. thirteen dollars seventy-five cents—12 do. fifteen dollars,—per annum, if occupied by one family. An additional charge of three dollars will be made for each extra family.—All Grocery Stores, ten dollars per annum, and fountains 10 dollars each —Stores and Offices without families, five dollars per annum.—
Bake Houses ten dollars per annum for each Oven—Factories,
Buildings, Boarding Houses, Taverns, Distilleries, Breweries, Dye Houses, &c. according to private agreements.

6. The supply of water will not be discontinued except on the 1st of

May and November, when all persons wishing to discontinue the supply will leave written notice to that effect, at the WATER OFFICE, (No. 7 Reed-st.) otherwise they will be considered as subscribers.

The public are respectfully informed, that the Water Works, having undergone a thorough repair, the supply is great and permanent, in every part of the city—so that any persons wishing water for Factories, Breweries, &c. or for private houses, may be assured of a constant and regular supply, where the lateral pipes are in good order. New main Logs will be laid in any part of the city, on application of a sufficient number of subscribers to warrant the expense. JOHN LOZIER, 1827. Superintendent Water Works.
