trustee shall cease on the due organization of said board of education.

§ 11. Additional territory may be annexed to the school-district number one, as prescribed by law for alterations in school-districts, and when so enlarged, all the provisions of this act remaining in force, shall apply.

## Chap. 811.

AN ACT to legalize certain action of the Common Council of the city of New York, and proceedings thereunder.

Passed May 8, 1867.

*The People of the State of New York, represented in Senate and Assembly, do enact as follows:*

SECTION 1. The resolution of the mayor, aldermen and commonalty of the city of New York, approved by the mayor of said city December nineteen, eighteen hundred and sixty-two, authorizing William C. Rhinelander, surviving executor of William Rhinelander, deceased, to construct a pier upon his property in the North river in the city of New York, to extend from the bulkhead in West street to the commissioners' line of pier heads, is hereby declared to be of lawful and of binding force, and the pier now erected upon and in front of said property is hereby declared to be a lawful structure.

§ 2. This act shall take effect immediately.

## Chap. 812.

AN ACT to enable the county of Onondaga to obtain a supply of water for the county poor-house.

Passed May 8, 1867; three-fifths being present.

*The People of the State of New York, represented in Senate and Assembly, do enact as follows:*

SECTION 1. For the purpose of supplying the county poor-house in the county of Onondaga with water, said county, through the superintendent of

the poor thereof, may take the same proceedings in relation to any waters, streams or springs in the vicinity of said county poor-house, and the purchase and taking of such waters, streams and springs, and the land connected therewith, as the Syracuse city water works company is now authorized by law to take ; and, for the purpose aforesaid, all the provisions in relation to making surveys and taking waters, streams and springs, and the appraisal thereof, and the compensation therefor contained in the act entitled "An act to incorporate the Syracuse city water-works company," passed April fifth, eighteen hundred and forty-nine, and the several acts amending the same, are hereby made applicable to said county of Onondaga acting in the manner aforesaid ; but the three streams lying north and west of said poor-house, known respectively as the Furnace, Kenyon and Loomis brooks are expressly excepted from the operation of this section.

§ 2. The costs, charges and expenses necessarily incurred in the proceedings under the first section of this act, including compensation for waters, streams, springs and land shall be a charge upon said county of Onondaga, and shall be levied and collected as other county charges by the board of supervisors of said county.

§ 3. This act shall take effect immediately.

## Chap. 813.

AN ACT to amend an act entitled "An act to authorize certain towns in the counties of Ulster and Orange to issue bonds and take stock in the Wallkill Valley Railroad," passed May ninth, eighteen hundred and sixty-six.

Passed May 9, 1867 ; three-fifths being present.

*The People of the State of New York, represented in Senate and Assembly, do enact as follows :*
