#### No. 82.

### AN ACT

To repeal certain sections of an act, entitled "A supplement to an act anthorizing the borough council of the borough of Bethlehem, Pennsylvania, to purchase the water works, real estate and improvements of the Bethlehem Water Company; also to make all such necessary improvements and extensions required, to borrow money and appoint commissioners to carry out said object, approved the thirtieth day of March, Anno Domini one thousand eight hundred and sixtysix, to authorize the election of water commissioners, to borrow money and collect the water rents," approved nineteenth day of May, Anno Domini one thousand eight hundred and seventy-one.

SECTION 1. Be it enacted, &c., That sections one, two, four Repeal and five of the act of the nineteenth day of May, Anno Domini one thousand eight hundred and seventy-one, entitled "A supplement to an act authorizing the borough council of the borough of Bethlehem, Pennsylvania, to purchase the water works, real estate and improvements of the Bethlehem Water Company; also to make all such necessary improvements and extensions required, to borrow money and appoint commissioners to carry out said object, approved the thirtieth day of March, Anno Domini one thousand eight hundred and sixty-six, to authorize the election of water commissioners, to borrow money and collect the water rents," be and the same are hereby repealed.

SECTION 1. Be it enacted, &c., That the act, entitled "A Act repealed. supplement to an act authorizing the borough council of the borough of Bethlehem, Pennsylvania, to purchase the water works, real estate and improvements of the Bethlehem Water Company, and so forth," approved the twenty-seventh day of March, Anno Domini one thousand eight hundred and seventy-three, be and the same is hereby repealed.

To repeal certain sections and provisions contained in an act, entitled "An act authorizing the borough council of the borough of Bethlehem, Pennsylvania, to purchase the water works, real estate and improvements of the Bethlehem Water Company; also to make all such necessary improvements and extensions required, to borrow money and appoint water commissioners to carry out said object," approved thirtieth day of March, Anno Domini one thousand eight hundred and sixty-six.

Certain sections repealed.

SECTION 1. Be it enacted, &c., That sections one, eight and nine of the act of thirtieth day of March, Anno Domini one thousand eight hundred and sixty-six, entitled "An act authorizing the borough council of the borough of Bethlehem, Pennsylvania, to purchase the water works, real estate and improvements of the Bethlehem Water Company; also to make all such necessary improvements and extensions required, to borrow money and appoint water commissioners to carry out said object," be and the same are hereby repealed.

SECTION 2. That the words "said commissioners in conjunction with" and the words "commissioners and," whenever they appear in the second section of said act, be and

the same are hereby stricken out and repealed. Section 3. That the words "and commissioners" and the words "and water commissioners," whenever they appear in the third section of said act, be and the same are hereby stricken out and repealed.

Section 4. That the words "and water commissioners and their successors in office," whenever they appear in the fourth section of said act, be and the same are hereby stricken out and repealed.

Section 5. That the words "and water commissioners" and the words "in council asssembled," whenever they appear in the sixth section of said act, be and the same are hereby stricken out and repealed.

### No. 86. AN ACT

Making appropriations for the salaries of officers and employes, for insurance, and for the improvement of grounds, building and machinery, of the Western Pennsylvania Hospital, Pennsylvania.

SECTION 1. Be it enacted, &c., That the following sums be, Appropriations and the same are hereby specifically appropriated to the for 1877 Western Pennsylvania Hospital, for the several objects hereinafter named, for the year commencing on the first day of June, Anno Domini one thousand eight hundred and seventyseven: For the payment of salaries and wages of officers and employes, the sum of thirty thousand dollars; for insurance, one thousand dollars; for enlarging laundry, and new machinery, four thousand five hundred dollars; for new hot water boiler and enlarging steam boiler, fourteen hundred dollars; for erection of carpenter and general repair shop, thirty-five hundred dollars, and for addition to barn the sum of fifteen hundred dollars.

SEDTION 2. That the following sums be and the same are Appropriation hereby appropriated to the Western Pennsylvania Hospital for 1878. for the Insane, at Dixmont, Pennsylvania, for the several objects hereinafter named, for the year commencing on the first day of June, Anno Domini one thousand eight hundred and seventy-eight: For the payment of salaries and wages of officers and employes, the sum of thirty thousand dollars, and for insurance on buildings one thousand dollars; the said appropriations provided for in the first and second sections of this act, shall be paid quarterly out of any moneys in the treasury not otherwise appropriated, as follows, namely: On the first days of July, October, January and April of each year.

SECTION 3. For the maintenance of patients, repairs to Appropriation buildings and improvements to grounds of the general hos- 12th ward, Pittspital, in the Twelfth ward, city of Pittsburgh, the sum of burgh. fifteen thousand dollars; the said amount provided for in this section shall be paid quarterly out of any moneys in the Treasury not otherwise appropriated, namely: On the first days of July and October, Anno Domini one thousand eight hundred and seventy-eight, January and April, Anno Domini one thousand eight hundred and seventy-nine.

Section 4. The state treasurer shall not disburse any of Salaries to be re the moneys herein appropriated, until satisfactory proof has duced. been made to him that the following reductions have been made in the salaries of all officers and employés engaged in
