### A Supplement

To the several acts incorporating the city of Pittsburg.

WHEREAS, The councils of the city of Pittsburg have caused to be prepared, and have by ordinance adopted, in the form of a code, certain ordinances for the said city, including therein ordinances now in force with amendments and additions thereto:

And whereas, The acts of assembly relating to said city require that all ordinances shall be published and recorded in the office for recording deeds, et cetera, in and for the county of Allegheny, and it would be inconvenient and expensive to publish and record said code; therefore,

SECTION 1. Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That said ordinances so adopted shall, upon the passage of this act, become effective and valid as ordinances of said city; and all ordinances or parts of ordinances inconsistent therewith or thereby supplied shall be repealed; and any law requiring ordinances of said city to be published or recorded shall not be held to apply to the code so adopted: Provided, That a copy of the code when printed shall be filed in the office of the recorder of deeds aforesaid.

SECTION 1. Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, 58

## An Act

To extend the time for collection of bounty tax in the borough of Tarentum.

SECTION 1. Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same. That the warrant issued to Robert Gilleford by the burgess and council of the borough of Tarentum, bearing date of June the eighteenth, one thousand eight hundred and sixty-six, for the collection of a bounty tax in the borough of Tarentum, Allegheny county, be and the same is hereby renewed and revived, with full power and authority, for one year after the passage of this act, and he is hereby authorized to collect the tax due under the same, as if the said warrant had not expired.
