An Act

Authorizing the burgess and town council of the borough of Etna. in Allegheny county, to borrow money and levy a special tax for borough purposes.

Section 1. Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That the burgess and town council of the borough of Etna, Authorized to borin Allegheny county, are hereby authorized and empowered row money. to borrow any sum of money, not exceeding two thousand dollars, at a rate of interest not exceeding seven and threetenths per cent. per annum, and issue bonds therefor in such sums as they may see fit, payable at any time not exceeding ten years from the passage of this act; which money, thus bounded, shall be used by the burgess and town council in improving the pavements and streets of said borough, and for other purposes.

SECTION 2. The said borough authorities are hereby author- Authorized to levy ized to levy and collected an additional or special tax not ex- a special tax. ceeding in any one year five mills upon the dollar, upon all property now by law made taxable for county and state purposes, for a period not exceeding ten years, for the purpose of liquidating any debt contracted under the provisions of this act.

An Act

Supplementary to an act incorporating the Mechanicsburg Gas and Water Company of Cumberland county, passed the fifth day of May, Anno Domini one thousand eight hundred and fifty-four.

Section 1. Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That the Mechanicsburg Gas and Water Company be authorized to effect a loan, not exceeding fifty thousand dollars, and for the security and re-payment of the same, to pledge the faith, credit and property of the said company; and as evidence of said indebtedness, the company shall have power and authority to execute and deliver their bonds, under the seal of the corporation and signature of the president of the company, in sums not less than one hundred dollars, with interest coupons attached, bearing a rate of interest, not exceeding eight per centum, payable semi-annually: Provided honever, That said bonds shall be made payable according to negotiations of the parties at not more than ten years from their date.

An Act

To authorize and empower Mary Reinert, widow of John Reinert, late of Berks county, deceased, to sell certain real estate.

Whereas, John Reinert, late of Berks county, Pennsylvania, deceased, by his last will and testament, dated the twenty-fourth day of September, Anno Domini one thousand eight hundred and thirty-nine, did among other things devise to his wife, Mary Reinert, the "full use, benefit and enjoyment of all his houses and lands during the term of her natural life or widowhood," and after her death or re-marriage then be sold, and the proceeds to be distributed among his children:

And whereas, The estate of said decedent was at the time of his death subject to the lien of various debts, which his widow has since discharged and paid out of her own private means:

And whereas, The said real estate is in a very dilapidated condition, much in want of repairs, and has become wholly unproductive, and that therefore it would be greatly to the advantage of all parties interested in said estate to have the same sold; therefore,
