A SUPPLEMENT to an act authorizing the Governor to incorporate the Milford Cold Spring water company passed the fifth day of April one thousand eight hundred and forty-nine

1 SECTION 1 *Be it enacted by the Senate and House of Repre-*  
2 *sentatives of the Commonwealth of Pennsylvania in General Assembly*  
3 *met and it is hereby enacted by the authority of the same That*  
4 the said president and managers shall in such streets or parts of the town  
5 where pipes or otherwise shall be laid erect three fire hydrants one at the  
6 corner of Hartford and Broad streets one in Hartford and one in Broad  
7 street to be used exclusively and solely for extinguishing fires and they shall  
8 have liberty at all times where the pipes or otherwise shall be laid in and  
9 through any of the streets of said town to suffer individuals to be supplied  
10 with water for domestic use and such other uses as the president and mana-  
11 gers may permit for such reasonable compensation as shall from time to time  
12 be agreed upon by said company and such individuals according to such uni-  
13 form rates as the said president and managers shall hereafter adopt *Provided*

14 That the owners of the freehold on and upon which said water is so taken  
15 and used be liable for and that the real estate be bound for the payment of  
16 the same

1 SECTION 2 That if any person or persons who shall have contracted with  
2 said company for the use of said water shall wantonly or unnecessarily waste  
3 the same to the injury of the said company or shall permit any other person  
4 or persons not being by the said contract entitled to the use thereof to make  
5 use of the same or shall neglect and fail to pay to said company the  
6 amount of money by him her or them agreed upon to be paid as a com-  
7 pensation for the use of said water for three months after the same shall be  
8 due and payable according to the terms of said contract it shall be lawful  
9 for the president and managers to withhold and cut off such water from the  
10 premises of such person or persons until all such damages with the interest  
11 and cost of recovering the same be fully paid *Provided* That nothing herein  
12 contained shall be so construed as to affect impair or take away the right  
13 of the said company to sue for and recover the amount of such damages

1 SECTION 3 That the whole of section eight and so much of the several  
2 sections of the act to which this is a supplement as is inconsistent herewith  
3 or altered hereby be and the same is hereby repealed
