Zu Act

Supplemental to an act incorporating the Williamsport Water Company.

Section 1. Be it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same, That the Williamsport Water Company be and are hereby authorized and empowered, for the purpose of extending, enlarging and perfecting their works, to borrow any sum or sums of money, not exceeding sixty thousand dollars, at such rate of interest, not exceeding twelve per cent per annum, and payable at such times as may be agreed upon; and as security for such loans, the president and secretary of said company are hereby authorized and empowered to execute judgment notes in the name and under the corporate seal of said company: Provided, That such notes may be entered in the court of common pleas of Lycoming county, as judgments of an individual are now entered in said court, and be from the date of such entry a lien upon all the corporate rights, powers. privileges, franchises and property, real, personal and mixed of said company: And provided further, That all the corporate rights, powers, privileges, franchises and property, real, personal and mixed, of said company, shall be subject to levy and sale upon writ of fieri facias issued upon such judgments, in the same manner as the personal property of an individual is now by law subject to levy and sale: And provided further, That the purchaser or purchasers, his, her or their heirs, executors, administrators, successors or assigns of the corporate rights, powers, privileges, franchises and property, real, personal and mixed, of said company, at such sheriff's sale, shall have, hold and exercise the same in the same manner, with the same power and under the same authority, as they were held and exercised by the said company.

A Supplement
