#### CHAPTER CVIII.

#### AN ACT

Authorising the Governor to incorporate the Womelsdorf Water Company.

SECT. 1. BE it enacted by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, and it is hereby exacted by the authority of the same, That Peter Ecker, Frederick A. Sect. 2. And be it further enacted by the authority aforesuid. That when thirty or more persons shall have subscribed two When letters hundred or more shares of the said stock, the commissioners patent may shall certify under their hands and seals the names of the the company subscribers and the number of shares subscribed by each, to the governor of this commonwealth, and thereupon it shall be lawful for the governor u der his hand and the seal of the state to create and erect the subscribers, and also those who shall afterwards subscribe, and their assigns into one body politic and corporate, in deed and in law, by the name, style and title of "The Womelsdorf Water Company," by which Style. name the said subscribers shall have perpetual succession, Powersand and all the privileges and franchises incident to a corpora-

tion, and shall be capable of taking and holding the capital stock and the increase and profits thereof, and of enlarging the same by new subscriptions, if it shall be found necessary to fulfil the intent of this act, and of purchasing, taking and holding to them, their successors and assigns, and of selling and transferring in fee simple, or for any less estate, such lands, tenements, hereditaments and estate real or personal as shall be necessary in the prosecution of their works, and of suing and being sued, and of doing every matter and thing which a corporation or body politic may lawfully do.

SECT. 3 And be it further enacted by the authority aforesaid. That any three or more of the said commissioners shall, as Notice of the soon as conveniently may be after the letters patent are obtained, give at least ten days notice, in one or more newstime and place of or-papers printed in the county of Berks, or by printed hand-

shall be given in one or more newspapers printed in the county of Berks; and when vacancies happen, the managers shall supply them from among the stockholders until the next annual election: Provided, That no misnomer nor Provise. failure of election of officers on the day appointed shall discontinue or dissolve the said corporation, but the managers and officers shall continue in office until a new election, which shall be made at such time and place within the said town, and after such notice, as the board of managers may prescribe.

SECT. 4. And he it further enacted by the authority aforcaid. Power to That the president and managers, or any three of them, shall make by-have power to adopt such by laws, rules and regulations, as laws, &c. shall not contravene the constitution and laws of the United States or of this commonwealth, and may be necessary or expedient for the well governing the affairs of the company; and they shall also have power to call special meetings And call of the stockholders whenever any circumstances occurspecial meet, which may render it necessary to consult them.

SECT. 5. And be it further enacted by the authority aforesaid, That the president and managers shall procure a common of the seal. seal, and the certificate of stock and other official acts shall be authenticated by affixing the same; and the president and Of certifimanagers shall procure certificates for all the shares of the cates of stock of the said company, and shall deliver one such certi-stock. ficate, signed by the president and countersigned by the treasurer, and sealed as aforesaid, unto such person, for every share held by him or her, as soon as ten dollars shall be paid on such share; and every such certificate shall be of their transferable in person or by attorney duly authorised, in the transfer. presence of two witnesses, subject, however, to all payments due and to become due thereon; and the assignee holding any certificate having first caused the assignment to be entered in a book of the company to be kept for that purnose, shall be a member of the corporation, and possess and Rights and enjoy all the rights, privileges, benefits and emoluments to powers of which he would have been entitled if he had been an origin-assignees.

Sect. 6. And be it further enacted by the authority aforesaid,
That the president and managers shall meet at such times and Of special

 $\mathbf{Sect.7.}$  And be it further enacted by the authority aforesaid, Water to be That it shall be the duty of the president and managers, as the town by soon as may be after the company shall be organised, to proceed to bring and convey into the town of Womelsdorf, by means of pipes, trunks or aqueducts, or other means, some spring or stream of water from the neighborhood of the said town, the right of which shall have been previously vested in the said company, and also to provide proper cisterns or reservoirs for the reception thereof; and for the purpose aforesaid they may enter into such lands and enclosures as may be necessary, and to dig ditches and lay pipes and trunks through the same, doing as little damage as possible to prirate property, and paying for whatever injury shall be done by them; when the parties cannot agree, according to the Proceedings assessment made, under oath or affirmation, by three disinterested persons, to be appointed, on application, by the court of common pleas, in and for the county of Berks; and the said president, and managers shall at all times (paying the damages as aforesaid) have liberty to renew and repair the said pipes or trunks wherever laid, and shall also have liberty at all times to dig and lay pipes or trunks along roads and highways, and along the streets and alleys and public grounds in the said town, and to renew and repair the same, shutting up and amending any breaches which they may make as soon as possible; and it shall also be lawful for them to make cisterns or reservoirs in the streets or public grounds in the said town where the same may be deemed necessary.

SECT. 8. And be it further enacted by the authority of oresaid, That the said president and managers shall in such streets or parts of the said town where pipes shall have been laid, erect hydrants to be used solely for the extinguishment of fires; and they shall suffer individuals at all times to be supplied with water from the said pipes for domestic or manufacturing use, for such reasonable compensation as shall from time to time be agreed upon by the said president and managers, and such individuals according to certain uniform rates which the said president and managers shall hereafter adopt, having agreed to the probable quantity of water which applicants are likely to consume, and the distance from the place whence the water is to be drawn. And any person within said town who shall take away any of the water for domestic without per or manufacturing use without having previously contracted for the same with the said president and managers, shall for-

feit and pay for every such offence the sum of one dollar to the said president and managers, to be recovered before a justice of the peace in the same manner as debts of equal amount are by law recoverable: Provided, That nothing Provisor herein contained shall be construed to compel the inhabitants of said town to use the water so introduced by the said company, or to prevent them from using water obtained in any

Sect. 9. And be it further enacted by the authority aforesaid, That the president and managers shall call in the capital Capital stock stock of the said company by instalment, as the same may to be paid by be requisite for the prosecution of the said work; and if any instalments. stockholder shall neglect to pay his instalments after thirty neglecting days notice published in one or more newspapers published to pay them. in the county of Berks, the payment thereof may be enforced as in other cases. SECT. 10. And be it further enacted by the authority aforesaid. That any person who shall wilfully destroy or injure in any Penalty on manner the pipes, aqueducts, cisterns, or reservoirs, hy-persons for drants, buildings, or machinery, or any of the works of the injuring said company erected in pursuance of this act, or shall wil-works or corfully corrupt or otherwise render unwholesome the spring or rupting wastream of water which will be conveyed or brought into the ter. town of Womelsdorf by the said company, shall on being thereof convicted before any justice of the peace in and for the county of Berks, by oath or affirmation of one or more credible witnesses, pay a fine not less than five nor more than twenty dollars, one half to the use of the poor of the county of Berks, and the other half to the informer, and shall moreover be

liable for all damages to the company.

Sect. 11. And be it further enacted by the authority aforesaid, That if the said company shall not proceed to carry on the Time for said work within five years after the passing of this act, or commencing shall not within ten years afterwards complete the same so and completfar as to have conveyed the water within the limits of said ing the work town, all and singular the rights, liberties and franchises hereby granted to the said company shall revert to this coma monwealth.
