SEC. 1. It is hereby enacted by the General Assembly of Persons associ- the State of Vermont, That whenever any number of perating for supply- sons shall associate for the purpose of supplying any town, district, neighborhood or village in this state with water by means of an acqueduct, such association so formed is hereby made and constituted a body corporate and politic, in deed and in name, by such name and style as a majority of the members of said association may agree upon, and by such name may sue and be sued. plead and be impleaded, may purchase, hold and convey so much personal and real estate as may be necessary to carry into effect the object of such association, may have a common seal and the same alter at pleasure, and enjoy all the privileges and powers incident to corporations for the purpose of making, repairing and enjoying an acqueduct and all the benefits and privileges thereof.

It is hereby further enacted, That each and SEC. 2. every corporation so formed shall have full power to make their own by-laws and regulations, such as appointing the time and place of holding their meetings, regula-Further powers ting the mode of electing their officers, determining the authority and duty of each officer, dividing the stock of said corporation into as many shares as they may deem proper, and establish the mode of transferring the same

either by private sale, or the payment of such assessments and taxes as may be ordered and directed by said corporation-which shares shall be considered personal Shares in same estate to all intents and purposes, and when any share to be personal or shares shall be attached on mesne process, an attested estate. copy of such process and of the officer's return thereon How attached. shall be by the officer serving the same lodged with the clerk of said corporation, otherwise the writ or attachment shall be void, and said shares may be sold in the same manner as is provided for the sale of any other How sold. personal property, and the officer serving the execution, by virtue of which such sale shall be made, shall leave a copy of said execution, with his returns thereon endorsed, with the clerk of said corporation within twelve days next after such sale, and said share or shares so sold as aforesaid shall to all intents and purposes be vested in the purchaser.
